Public Meeting Notice

You're invited to participate in an Online Public Meeting Monday, February 8, 2021 at 5:00 pm

A change is proposed in your neighbourhood: The proposed Zoning By-law Amendment is seeking to rezone the subject lands from Residential One (R1) to Residential Three (R3-Exception). The amendment also addresses Section 6.34 v of the Zoning Bylaw such that the principal townhouse dwelling is not required to be situated on a separate parcel before a secondary dwelling may be permitted. The proposed Official Plan amendment is seeking to increase the maximum permitted density from 40 units per hectare to 54 units per hectare. If approved, the proposed amendments will allow development involving four (4), 1.5 storey townhouses each with a secondary dwelling unit above resulting in a total of 8 units. The lower units will be partially below grade.

Know your rights

Section 17(36) of the <u>Planning Act</u> outlines rights of appeal for Official Plan Amendment applications.

If a person or public body would otherwise have an ability to appeal the decision of the County of Bruce to the Local Planning Appeal Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to the Bruce County Planning Department before the proposed official plan (or official plan amendment) is adopted, the person or public body is not entitled to appeal the decision.

If a person or public body does not make oral submissions at a public meeting or make written submissions to the Bruce County Planning Department before the proposed official plan (or official plan amendment) is adopted, the person or public body may not be added as a party to

the hearing of an appeal before the Local Planning Appeal Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to add the person or public body as a party.


Section 34(11) of the <u>Planning Act</u> outlines rights of appeal for Zoning By-law Amendment applications.

If a person or public body would otherwise have an ability to appeal the decision of the Council of the Municipality of Kincardine to the Local Planning Appeal Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to Bruce County Planning Department before the by-law is passed, the person or public body is not entitled to appeal the decision.

If a person or public body does not make oral submissions at a public meeting, or make written submissions to the Bruce County Planning Department before the by-law is passed, the person or public body may not be added as a party to the hearing of an appeal before the Local Planning Appeal Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.
