# A by-law to adopt Amendment Number C-2021-006 to the County of Bruce Official Plan

#### Part B - The Amendment

### **Introductory Statement**

All of this part of the document entitled "Part B – The Amendment" and consisting of the following text, and attached map designated as Schedule "A", constitutes Amendment Number C-2021-006 to the Bruce County Official Plan.

The Official Plan Amendment is to add a site-specific 'Pits and Quarries' overlay to a portion of the subject property to enable an Aggregate Resources Act license to be issued.

#### The Amendment

- 1. Schedule A: Land Use is amended by changing the designation on the lands at North Part Lot 10, Concession 24 North, RP 3R 9766 Part 1, geographic Township of Amabel, Town of South Bruce Peninsula as shown on the attached Schedule 'A'.
- 2. The Bruce County Official Plan is amended by adding the following subsection to Section 4.8.7.XX Exceptions Mineral Resource Area:

"Sovie c/o Davidson (OPA 245)
Notwithstanding the policies of Section 4.8.5.2 (Locational Criteria – Mineral Resource Areas) of this Plan, 7.4 hectares may be licensed and 4.9 hectares extracted. Section 4.8.5.2 (ii) setbacks to adjacent dwellings used as hunting camps do not apply. Section 4.8.5.2 (iv) setbacks may be reduced to 30 metres from a watercourse or hazard land area, and zero metres in the hydrogeological constraint zone as outlined in the operational plan.
