Re: Q3 2022 Licensed Child Care and Early Years Report

#### **Staff Recommendation:**

The Q3 2022 Licensed Child Care and Early Years Report is for information.

## **Background:**


The priority of Bruce County Children's Services, a division of the Human Services department, is to ensure the local delivery of licensed child care and early years services is accessible, affordable, inclusive, and high-quality. The following performance indicators provide an overview of community trends and service delivery statistics for Q3 of 2022.

## **Licensed Child Care Applications:**

In an effort to better track, monitor, and respond to local system pressures, Bruce County uses OneList, an online child care registration system, to help families locate and apply for licensed child care. In turn, the system's data provides County staff with a snapshot of information, quantifying child care needs by demographic area. Beginning in Q2 2021, OneList has provided details about the number of applications where the child has a placement (but another program is requested) as compared to those with no placement.

The total number of active child applications in Q3 2022 has increased as compared to Q3 in 2021 by 279. Detailed information regarding the number of applications by municipality can be found on the previous table.

A new authorized recreation program operated by the Municipality of South Bruce opened in September 2022 in Teeswater, that provides before and after school care to approximately 30 children. As such, it is expected that waitlist numbers for this area may be reduced.


Licensed child care operating actuals continue to be impacted by a lack of qualified child care staff. Bruce County staff is co-leading a Bruce Grey Registered Early Childhood Educator (ECE) Recruitment and Retention Working Group that includes membership and support from local colleges, boards of education, workplace engagement services and corporate communications, to develop and implement local ECE recruitment and retention strategies.

## Fee Subsidy:

For eligible families, child care fee subsidy support is available through Bruce County Children's Services, with priority given to families with income levels lower than \$40,000 per annum.

Below is a comparison of the number of children receiving subsidy at Q3 2021, as compared to Q3 2022:



At Q3 in 2022, the average monthly number of children served in Bruce County's fee subsidy program was 203. This represents a decrease of 13 as compared to Q3 in 2021.

### **Special Needs Resource Program:**

The Special Needs Resource Program provides supports for the inclusion of children with special needs in licensed child care programs, camps, and authorized recreation programs at no additional cost to parents or guardians.

In 2021, the Special Needs Resource program streamlined and enhanced their service approach in order to be more proactive and responsive to the inclusion needs of all children across Bruce County. The provision of universal inclusion strategies was identified as an important area of focus to build capacity within system. Additionally, short term consultation services and intensive, individual support were also identified as essential whenever needed.

The three levels of services of the Special Needs Resource Program are summarized below:

#### EarlyON Child and Family Centres:

EarlyON Child and Family Centres provide virtual and free in-person programs to help strengthen adult/child relationships, support parent education, and foster healthy child development. All families with children from birth to six years of age are encouraged to participate.

EarlyON to Go take home bags were put on pause for Q3 in 2022. A decision was made to offer three EarlyON to Go programs annually and dates were selected based on seasonal factors to support families. The bulk of EarlyON programs are now in-person and, as such, virtual options have decreased in Q3 2022 as a result.

Programs and visits decreased in Q3 2022 which is typical for summer offerings. The decrease in Facebook visits may be linked to seasonal factors which would align with the decrease in in-person attendance.
