Background:

This report is intended to be a template to help facilitate the discussion to appoint Committee Chairs and appointments to the various boards and committees.

The County of Bruce uses a Standing Committee system. All Council Members serve on each Committee and the Chair of the Committee is selected annually by Council.

The Warden will lead Council through a process to select Committee Chairs for the following Committees: Executive, Corporate Services, Human Resources, Human Services, Information Technology, Long Term Care Homes Committee of Management, Museum, Paramedic Services, Planning and Development, Transportation and Environmental Services.

The recommendation reflects the past practice for the Warden to serve as Chair of the Executive, Corporate Services and Human Services Committees; however, the recommendation can be amended to reflect Council's direction.

The discussion will take place in Committee of Whole and the recommendation for appointments will be presented and adopted in Agenda Item 13 of the Council Agenda.

Council is also required to appoint members to the following Committees and Boards:

Grey Bruce Board of Health - the Warden and 2 Members to be appointed

Bruce County Library Board - the Warden and 3 Members

The Members shall represent the North (Northern Bruce Peninsula, South Bruce Peninsula), the inland area (Arran-Elderslie, Brockton and South Bruce) and the Coast (Huron-Kinloss, Kincardine and Saugeen Shores).

Nuclear Innovation Institute - 1 Member

Green Ribbon Panel - 1 Member

Clean Energy Frontier - the CAO and 1 Member

Accessibility Advisory Committee - the Warden and 1 Member

Community Drug and Alcohol Strategy - 2 Members

Southwestern Integrated Fibre Technology Board of Directors (SWIFT) - 1 Member
