**Re:** Transfer of Bruce Road 23 from Municipality of Kincardine to County of Bruce

## Staff Recommendation:

That a by-law be introduced to establish portions of Bruce Road 23 as public highway within the jurisdiction of the County of Bruce.

### **Background:**

Staff from the Municipality of Kincardine approached County staff requesting that we work together to transfer Bruce Road 23 to the County of Bruce formally. The Real Estate Clerk researched the information at the Registry Office and confirmed that the Municipality of Kincardine is identified as the owner of portions of County Road 23, comprising of 5 PINS (see Figure 1).

County and Kincardine staff are in agreement that the road has been part of the County system for decades and this action will simply clean up the records on title at the Registry Office. The level of service and maintenance activities do not change due to this effort.

The original attempt to register the road was turned down by the Registry Office, citing a lack of documentation that the road was within the County's jurisdiction.

The legal advice received to correct this on title was:

- 1) County of Bruce to pass a by-law regarding the lands and register the bylaw on title of the subject land
- 2) Register an Application General for the subject lands amending the registered Owner name from the Municipality of Kincardine to the County of Bruce.

If this is not accepted, then;

- 1) Register a Change of Name Application for PIN 33303-0025 to amend the registered owner from The Corporation of the Township of Kincardine to The Corporation of the Municipality of Kincardine;
- 2) Register a Transfer from The Corporation of the Municipality of Kincardine to The Corporation of the County of Bruce for PINS: 33303-0025, 33303-0002 & 33293-0001;

3) Bruce County will pass a By-Law regarding the lands contained in PINS 33287-0349 and 33293 - 0640 which will be registered on title to the subject lands; 4. Register an Application General - to change name from Public Authority Having Jurisdiction to The Corporation of the County of Bruce for PINS 33287-0349 and 33293 - 0640.


