My name is Ken MacMillan, I own the property at 582 Johnson St, Port Elgin adjacent to the proposed notice site.

My property is directly to the East of this notice proposal. The impact to my property will be significant.

My property has been in my family since 1996 and I purchased the property from my father. We loved the mature neighbourhood and the fact that we lived beside a designated heritage home was part of our decision to buy, build and reside in down town Port Elgin. I have some questions that I need answered, and I am in opposition to this proposed development.

There seems to be some very bad decisions being made to cram new apartments in between heritage homes, and ruin the cultural landscape of the legacy down town of Port Elgin. There are many run down houses, empty lots and existing building areas that this proposed apartment should be placed somewhere other than this location.

The large mature trees and neighbourhood will be impacted greatly. The existing trees are already under stress and the excavation and building of this proposed building will be the end of the trees.

What happened to the heritage designation of the property that this apartment will crowd over?

The map provided shows a 6 foot lot line to the building. This also concerns me greatly as the overhang from the roof and potential building attachments (decks patios) will reduce my privacy and affect the amount of natural light on that side of my house. This deeply concerns me.

I received this letter on April 5th, 2023 and it seems a little under handed that the letter arrived the same day as the response was expected.

The employees at town office gave me your card when I asked who I should direct my concerns.

I realize I am late on submitting my concerns on the original application. I hope it will matter when they come back to committee with a counter proposal.

I have few issues with the proposed development.

I worry a three story apartment as proposed has no way of being compatible with the current neighbourhood, unless they are comparing to the stripe of businesses along Goderich. An imposing three story apartment building would darken the neighbourhood removing canopy and greenspace.

Parking is a major concern for me. I feel there should be one handicap space for each accessible unit. Having more cars backing onto Waterloo at any intersection is a hazard and a disaster waiting to happen. The bed and breakfast rarely had a full parking lot so it wasn't an issue before. It is already a challenge to get parking when conducting business in said stripe of businesses on Goderich at Johnston. Having apartment dwellers using up the few spots on Johnston is short sighted. I am also concerned who is responsible for the year round maintenance of the inlay parking spots proposed on Johnston, say snow removal and such.
