Report Purpose:

The 2023 Council Statement of Remuneration report is for information.

Report Summary:

The Remuneration and Expenses were paid according to By-Law 2022-001. Total payments for the year were 317,084. The statement for the same period in 2022 totaled \$275,044. Increased costs in 2023 were related mainly to mileage as the County returned to full in person meetings and conference attendance.
