Subject: Grey Transit Route

Recommendation:

That Council direct staff to work with Grey County to extend the Grey Transit service Route 5 beyond September 2, 2024, to December 31, 2024;

And That discussions pertaining to Grey Transit Routes beyond 2024 will take place during the 2025 budget deliberations.

And That Council direct staff to enter into a cost-sharing agreement with Bruce County to fund Route 5 of the Grey Transit Route from September 2, 2024, to December 31, 2024.

And Furthermore that the additional cost of \$26,500 be financed by the Municipal Accommodation Tax Reserve #34012.

Background:

The Grey Transit Route (GTR) was established in 2020, Route 5 which services South Bruce Peninsula has become a crucial transportation link for residents, connecting Owen Sound to Wiarton with stops at Springmount at No Frills, Allen's General Store in Shallow Lake, Hepworth Visitor's Centre, Wiarton Foodland, and Louisa Street. As the route marks its fourth year of operation, its future is rather dismal, with no commitment from the province for funding beyond 2025. At their February 22, 2024, meeting, Grey County Council voted to withdraw County levy funding for the GTR in the 2024 budget. To bring operating costs down, all weekend GTR service will end at the end of April 2024 and Route 5 being the Owen Sound to Wiarton route will be discontinued after Labour Day. For further efficiencies, routes will see some stop locations removed. The Shallow Lake stop will be removed from Route 5. GTR service will continue at the current level until the end of April. As it stands now, the GTR service in its entirety will be discontinued in March of 2025 without additional funding from the Provincial Government. If longer-term financial support is made available by the province, then any further funding requests for 2025 and beyond will be included in future budget deliberations.

This report shows financials for the operation of the Grey Transit Route 5 from its inception in 2020 through 2024. The financial overview includes a breakdown of expenses and funding sources. Notably, the expenses for the current year, 2024 are only to the present date, and are aligned with the approved budget for Grey County.

It should be noted that South Bruce Peninsula does not contribute any funding for Route 5 from Owen Sound to Wiarton. However, the municipality does support an extension to route 5 from May 1st to Labour Day that brings the route into Sauble Beach. This route is funded with a 50% cost-sharing agreement with Bruce County. The operational cost for this Sauble Beach extension amounts to \$83,000, inclusive of HST. This expense is evenly divided between Bruce County and South Bruce Peninsula, with each entity contributing \$41,500. Commuters utilizing the bus service are charged a fare of \$3.00 per trip. With the current state of the economy and cost of living, staff are not recommending an increase to the fare at this time.

With Grey County not financially supporting the service beyond September 2, 2024, staff would like to see a 50% cost-sharing agreement between South Bruce Peninsula and Bruce County Route 5 from September 2, 2024, to December 31, 2024, at the current service level. The total operational cost is \$53,000, with Bruce County and South Bruce Peninsula each paying \$26,500.

The expenses for the Grey Transit Route 5 have fluctuated over the years. It's important to note that these expenses include only contracted services, excluding salaries, benefits, advertising, and licensing which were covered internally by Grey County. The funding for the Grey Transit Route 5 comes from three sources: Provincial Grant, Grey County Taxes, and Fare Revenue.

The monthly costs to operate Route 5 beyond September 2, 2024, are estimated at \$13,250 per month, totaling \$53,000 for the remaining four months of 2024. This allows users a significant amount of notice to make other arrangements for travel as the service winds down.

The GTR provides South Bruce Peninsula residents with access to medical services at Brightshores in Owen Sound, which promotes better healthcare accessibility. Furthermore, it establishes an important link to larger transportation hubs, offering residents the means to travel seamlessly into major urban centres such as Guelph and the GTA. This not only opens up employment and education opportunities but fosters cultural and social engagement. In addition to enhancing connectivity, transit in rural communities plays a pivotal role in reducing carbon footprints by encouraging communal travel, thereby contributing to environmental sustainability.

Beyond these functional aspects, the GTR facilities cost-friendly and more diverse shopping options and social services, thereby enhancing the quality of life for our residents. The GTR has acted as a catalyst for improved healthcare, economic prospects, environmental responsibility, and community well-being. The loss of the GTR will have a significant impact on residents in South Bruce Peninsula.

Options:

- A. Do not support extending and funding Route 5 from September 2 to December 31, 2024.
- B. Approve the staff recommendations to fund and extend Route 5 from September 2 to December 31, 2024.

Inter-Departmental Impact:

It Council approves extending the service, then the Manager of Economic Development would work with the Director of Legislative Services on a cost sharing agreement with Bruce County.

Financial Implications:

Approval of Director of Financial Services/Treasurer

The Town currently supports the Rural Transit agreement through the use of funds from the Municipal Accommodation Tax Reserve #34012. It is the recommendation of this report to allocate an additional \$26,500 from the reserve to finance the additional costs required for the extension of Route 5.

Expected Date of Completion:

Staff would work with Grey and Bruce County to extend the agreement to December 31, 2024. If the Province does not come forward with support for Rural Transit, then then Route 5 would no longer provide service between Owen Sound and Wiarton as of December 31, 2024, and the GTR service as a whole would be discontinued once provincial funding ran out in March 2025.
