The meeting of Bruce County Council was called to order at 9:30 a.m.

7. Public Meeting

a. County Official Plan Amendment - C-2024-001 (Dales)

The Chair opened the Public Meeting for the Bruce County Official Plan Amendment C-2024-001 and Benito Russo, Planner presented the planning report. The Planner's

report recommended the amendment not be approved as it is not consistent with the Provincial Policy Statement.

In response to a question from a council member, Mr. Benito confirmed that the Teeswater River existed in 2019 when the surplus farm dwelling was created but the legal description included the entire retained lands. The legal description has since been updated to reflect the natural severance created by the river.

Dana Keiffer, Planner for the Applicant spoke in support of the application and provided the following summary of her professional opinion:

- a) The provincial policy that prohibits residential farm dwellings after a surplus farm dwelling severance is granted is not intended to extend across property boundaries to limit construction of residential buildings on adjacent separate parcels.
- b) The provincial policy is being met because the zoning restrictions are remaining on the retained lands south of the river, which are the lands subject to the 2019 application.
- c) The decision to place the zoning restriction across the entire lands was based on incomplete information. It is appropriate to review this application based on the new information and the fact that the restrictions of the surplus farm dwelling severance are being satisfied as the restrictions will remain on the lands located south of the river.

No members of the public spoke to the application.

Comments from the Members of Council included:

- The restrictions were applied across both of the separate properties through inadvertence as it was unknown there were two separate properties at the time of the surplus farm dwelling application. This is a unique situation. It seems reasonable to look at the property with the new information in mind and approve the application.
- Sterilizing the land through surplus farm dwelling severances results in less residential dwellings in areas that could actually benefit from more homes to support the school system etc.
- The Municipality of Brockton CBO had been consulted and he did not believe the Minimum Separation Distance would be a factor based on the distance to neighbouring barns.

b. County Official Plan Amendment - C-2024-002 (Naves)

The Chair opened the Public Meeting for the Bruce County Official Plan Amendment C-2024-002 and Jennifer Burnett, Senior Planner, presented the planning report. The Planner's report recommended the amendment be approved as it is consistent with the Provincial Policy Statement.

Don Scott, Planner for the Applicant spoke in support of the application and provided the following summary of his professional opinion:

a) There were no policy conflicts and he supports the staff recommendation No members of the public spoke to the application.

In response to a question from a member of Council, Ms. Burnett confirmed that details of the application were circulated in accordance with the notice requirements set out in the Planning Act, which includes registered landowners within 120 metres of the property and required agencies, but does not include customers of the campground.

A member of Council asked if a requirement to provide a physical barrier such as a screen or fence between the business and the campground could be imposed on the owner. Ms. Burnett noted that the local municipality can enforce a requirement for screening or other type of separation through the site plan control process, if desired.
