Report Summary:

Bruce County's Indigenous Reconciliation Planning Initiative has achieved significant milestones, culminating in the approval of the Indigenous Reconciliation Framework and the Saugeen Anishnaabek Reconciliation Pathway and Action Plan during the Special Bruce County Council Meeting on July 4, 2024. This report highlights the critical role of the Indigenous Reconciliation Steering Committee in guiding and delivering this initiative and advancing the County's reconciliation efforts.

Background/Analysis:

Beginning in January 2022, Bruce County embarked on a comprehensive Indigenous Reconciliation Planning Initiative, focusing on increasing cultural awareness through training and developing a Reconciliation Action Plan (RAP). This plan encompasses two essential documents: the Indigenous Reconciliation Framework and the Saugeen Anishnaabek Reconciliation Pathway and Action Plan.

Approved on July 4, 2024, the Reconciliation Framework and Pathway and Action Plan reflects Bruce County's commitment to building mutually respectful relationships with the Saugeen Anishnaabek. This achievement is a testament to the dedication and leadership of the Indigenous Reconciliation Planning Initiative Steering Committee, which played a critical role in shaping the County's reconciliation efforts.

The Steering Committee's contributions have been invaluable in ensuring that the County's reconciliation journey is inclusive, culturally informed, and aligned with the aspirations of the Saugeen Anishnaabek.
