

By-law Number 2025-021

A by-law to declare as surplus the part of Campbell Street/Bruce Road described as Part 1 on Registered Reference Plan 3R10967, being part of PIN 33333-0216 (LT) and to authorize the conveyance of the land to the Township of Huron-Kinloss

WHEREAS Section 9 of the *Municipal Act*, 2001, S.O. 2001, c.25, as amended, grants municipalities the capacity, rights, powers, and privileges of a natural person for the purpose of exercising its authority under this or any other Act; and

WHEREAS the Corporation of the County of Bruce ('the County") is the registered owner of the property known as Campbell Steet/Bruce Road 86 in the Village of Lucknow and identified as Part 1 on Registered Reference Plan 3R10967, in the Township of Huron-Kinloss; being part of PIN 33333-0216 (LT); and

WHEREAS the County, at its Council meeting on January 23, 2025, adopted the recommendation regarding the declaration of Part 1 on Registered Reference Plan 3R10967 to be declared as surplus to the needs of the County; and

WHEREAS the County, at its Council meeting on January 23, 2025, also directed to provide notice for the conveyance of Part 1 on Registered Reference Plan 3R10967 to the Township of Huron-Kinloss for the future expansion of the Lucknow & District Sports Complex and to enter into an Agreement with the Municipality regarding the transfer; and

WHEREAS notice of this by-law was posted on the Bruce County website and in the Lucknow Sentinel on April 9, 2025;

NOW THEREFORE the Council for the Corporation of the County of Bruce enacts as follows:

- 1. That the lands described as Part 1 on Registered Reference Plan 3R10967 in the Township of Huron-Kinloss; being part of PIN 33333-0216 (LT), and more particularly described in Schedule "A" attached hereto, be declared as surplus.
- 2. That the surplus lands described as Part 1 on Registered Reference Plan 3R10967 in the Township of Huron-Kinloss be transferred to the Township of Huron-Kinloss.
- 3. That the Warden and Clerk are authorized to sign the Transfer/deed of Land as well as execute all other documents necessary to complete the transfer herein.
- 4. This By-law shall come into full force and effect upon final passage.
