



## **By-law Number 2025-024**

### **A by-law to adopt Amendment Number C-2024-006 to the County of Bruce Official Plan**

**WHEREAS** authority is provided in Sections 17 and 21 of the *Planning Act*, R.S.O. 1990, as amended.

**NOW THEREFORE** the Council for the Corporation of the County of Bruce enacts as follows:

1. That Amendment Number C-2024-006 to the County of Bruce Official Plan attached as Part B and forming part of this by-law is approved.
2. This By-law shall come into force and take effect on the day of the final passing thereof, subject to the provisions of the *Planning Act*, R.S.O. 1990, as amended.

## **Part B - The Amendment**

### **Introductory Statement**

All of this part of the document entitled “Part B - The Amendment” and consisting of the following text, and attached map designated as Schedule “A”, constitutes Amendment Number C-2024-006 to the Bruce County Official Plan.


The Official Plan Amendment is to add a site-specific 'Pits and Quarries' overlay to the subject property to enable an Aggregate Resources Act license to be issued.

### **The Amendment**

1. Schedule A: Land Use is amended by adding a site-specific 'Pits and Quarries' overlay on the lands at CON 1 EBR LOT 4 (Albemarle Township), Town of South Bruce Peninsula as shown on the attached Schedule 'A'.
2. The Bruce County Official Plan is amended by adding the following subsection to Section 4.8.7.29 - Exceptions - Mineral Resource Area:

"Bruce Peninsula Stone c/o Cuesta (C-2025-006)

Notwithstanding the policies of Section 4.8.5.2 (Locational Criteria - Mineral Resource Areas) of this Plan, 40.04 hectares may be licensed and 26.50 hectares extracted. Notwithstanding Section 4.8.5.2.1 ii) a dimension stone quarry shall be permitted within 65 metres of a structure used for human habitation.
