Title: Forest Conservation By-law - Update

Staff Recommendation:

That Council directs a by-law to be brought forward to approve the recommended changes to the Bruce County Forest Conservation By-law.

Report Summary:

This report presents a series of housekeeping amendments to Bruce County's Forest Conservation By-law to enhance clarity, consistency, and transparency. These updates focus on refining definitions, clarifying permit application and approval language, and improving enforcement provisions. While the proposed changes are minor and administrative in nature, they support clearer guidance for landowners and more efficient implementation by staff.

A broader, more comprehensive review of the By-law is planned for 2026. That review will explore policy updates in areas such as personal use exemptions, fine structures, circumference-limit harvests, and a proposed 0.2-hectare woodlot designation. Future changes to be informed by broad public and stakeholder consultation. The goal of the 2026 review will be to align the By-law with current legislation and Bruce County's strategic and environmental policy framework (i.e., Strategic Plan, the Official Plan, and the Environmental Sustainability Action Plan).

Background/Analysis:

Bruce County's Forest Conservation By-law was enacted in 2004 to ensure the sustainable management of woodlands and to prevent overharvesting. The By-law applies to woodlands 1 hectare (2.5 acres) or larger and requires landowners to work with qualified forestry professionals to assess and mark harvests. A formal permit application must then be submitted and reviewed by County staff for compliance with sustainable forestry practices before a harvest can proceed. This regulation is particularly relevant for landowners who wish to harvest trees from their property.

Over time, language within the By-law has become inconsistent or unclear. Minor updates are now required to address terminology, streamline the permit process, and clarify the expectations for landowners and forestry professionals. These housekeeping amendments reflect current administrative practices and are intended to reduce confusion, support consistent enforcement, and improve the user experience.

Summary of Changes

The following housekeeping amendments are proposed:

Next Steps

Subject to Council's approval, the updated by-law will be shared with stakeholders. Communications materials will also be updated to reflect the clarified definitions and procedures, including any guidance provided to landowners, forestry professionals, and municipal partners.

Looking ahead, a comprehensive review of the Forest Conservation By-law is planned for 2026. This review will include meaningful consultation with a range of stakeholders, including (but not limited to) the public, local landowners, forestry professionals, and municipalities. The review will explore potential updates related to personal use exemptions, revised fine structures, the consideration of circumference-limit harvesting practices, and the introduction of a 0.2-hectare woodlot designation.

The overarching goal of the full review will be to modernize the By-law, ensuring alignment with current legislation and best practices in sustainable forest management. It will also support the implementation of key Bruce County priorities outlined in the Strategic Plan, Official Plan, and Environmental Sustainability Action Plan (ESAP).
