### 5. Reports

### a. CAO Performance Evaluation Policy Update

Jenn Robinson noted that the CAO Performance Evaluation policy has been in effect for one cycle. Staff have reviewed how the policy worked during this first term, and are proposing minor amendments to streamline the process, including standardizing who the members are that perform the evaluation each year, and moving the approval of the performance objectives to the meeting between the CAO and the members of Council performing the evaluation, rather than the final approval being provided by the Striking Committee at a later meeting.

The Committee agreed with the changes to the policy, but in the case of standardizing the participation of members to complete the CAO performance evaluation meeting, Warden Charbonneau asked if, during an election year, the process could be moved to an earlier timeframe to ensure that the final meeting of the CAO's performance review process takes place with members of Council who were in office during the term being evaluated. It was requested that the process be completed by the end of Q4 in an election year, rather than the current timeline which places the completion of the cycle at the end of Q1 of the following year.

Jenn Robinson advised that she would create a schedule with alternate timing to be used during election years, and add the schedule to the policy prior to presenting it to Council for final approval.
