Whereas that Bruce County Housing Corporation (the "Corporation") approves an Agreement for the Purchase of property in Kincardine, Ontario, which has been reviewed in consultation with the Corporation's Solicitor and with the Corporation of the County of Bruce, as the sole shareholder of Bruce County Housing Corporation and as the Service Manager pursuant to the Housing Services Act, 2011; and

Whereas the Corporation acknowledges having had the opportunity to review the Agreement in its entirety and the conditions and obligations contained therein, including a Confidentiality Clause which restricts/limits the Corporation's ability to disclose information to the public.

#### Therefore be it resolved:

- 1. That the Corporation is hereby authorized to enter into the Agreement for the purchase of a minimum of 4 acres, but no more than 5 acres, of land at the price stipulated therein, and located at Part Lots 16 And 17 Concession A Kincardine, Part 2 3R7390 Save And Except Parts 1, 2, 3 And 4 3R10042; Subject To An Easement In Gross Over Part 4 3R10072 As In BR131031; Municipality Of Kincardine; to be more particularly identified by a reference plan, for the purposes of a development project which will include affordable housing units and office space for Bruce County Human Services.
- 2. That Christine MacDonald, Director of Human Services, is hereby authorized to satisfy and/or waive any conditions contained in the said Agreement on behalf of the Corporation, at her discretion, in order to facilitate the purchase of the said land and the intended use and is hereby authorized to sign any documentation to that effect.
- 3. That Mitch Twolan, Warden and Donna Van Wyck, Clerk be designated and are hereby authorized to execute the Agreement on behalf of the Corporation and any and all necessary documents on behalf of the Corporation to effect the real estate transaction.
