- That the Clerk is hereby directed to forward the adopted Amendment together with the necessary supporting documentation to the County of Bruce for final approval.
- 3. **That** this by-law shall come into force and take effect pursuant to the provisions and regulations of the Planning Act, R.S.O. 1990, c.P.13.

#### **Details of the Amendment**


The Town of South Bruce Peninsula Local Official Plan is proposed to be amended as follows:

- 1. "Schedule A: Land Use Plan" to the Town of South Bruce Peninsula Official Plan is hereby amended by changing the land use designation on lands described as Part Park Lot P RP 3R7270 Parts 1 & 2 (Wiarton), Town of South Bruce Peninsula from 'Residential', 'Environmental Protection', and 'Rural' to 'Residential Special Policy Area #79', 'Environmental Protection', and 'Rural' as outlined in the attached Schedule "A".
- 2. Section 11.3.1 of the Town of South Bruce Peninsula Official Plan is hereby amended by adding the following:

## 11.3.1.79 Special Policy Area 79:

OPA No. 51 (Wright c/o Cuesta), By-Law 79-2019, Part Park Lot P RP 3R7270 Parts 1 & 2 (Wiarton)

Notwithstanding the policies of Section 11.5.15 Consent to Sever Land, the lands described as Part Park Lot P RP 3R7270 Parts 1 & 2 (Wiarton), may be severed to a minimum lot area of 3200 m<sup>2</sup>.
