[Draft] Terms of Reference - Natural Legacy Advisory Committee

What is our Natural Legacy?

- Lands owned by government and NGO trusts for conservation purposes
- Large areas of undisturbed and recovering forests
- Significant Wetlands, lakes, rivers and streams that provide habitat for a wide range of species and medicinal uses
- Areas that provide habitat for threatened and endangered species
- Areas that connect significant features that allow nature to work as a system
- Groundwater and surface water resources
- Stone, Sand, and Gravel Resources
- Forests that can be sustainably managed for wood, food, and medicinal uses

Need for Natural Legacy Planning

- Identify and protect resources from incompatible uses while encouraging sustainable harvesting and appropriate development
- Required by the Provincial Policy Statement to be identified in the Official Plan
- Prepare for and adapt to changing climate
- Support integrated planning with adjacent Municipalities
- Support ongoing Reconciliation with Indigenous people

Why a Natural Legacy Planning Advisory Committee

- Coordinated approach across the County to address different interests
- Support public engagement in the project
- Review and identify gaps in information
- Support a culture that values nature as a system and our role as stewards
